ACAS 申报

ACAS(Air Cargo Advance Screening)是美国国土安全部下面,CBP 和 TSA 两个部门,从 2010 年开始启动的空运安全管理试点项目。主要是针对空运进口,要求所有海外空运货代,在登机前,必须提交新的 ACAS 信息。

一飞软件是 2012 年开始参加这个试点项目, 2016 年开始, 已经带空运货代正式发送 ACAS 申报, 所以一飞软件 (E-Freight) 对 ACAS 的规章非常熟悉, 也乐于分享给同行。

ACAS 申报时间

- ❖ Air AMS 规定、航司必须在**到港前四小时**申报
- ❖ ACAS 申报,必须在登机前完成。
- ❖ 美国海关建议提交时间:越早越好,至少在打板前要确定已经收到海关 ACAS 申报回执。
 - 美国海关需要有足够时间完成安全评估
 - 申报时间太晚, 申报内容有错, 评估时间不足, 都会导致【不准登机】。
- DNL (Do Not Load) holding messages
 - 1. 6H Do Not Load Hold
 - 2. 7H Selectee Data issue Hold
 - 3. 8H Selectee Screening (or Verification) Required Hold

▲ 空运货代自己申报

- o 自己可以掌控发送回执,安排打板操作,如果收到不准登机信息,可以及时处理。
- o 建议在打板前确认所有分单已经拿到 SF 状态。

▲ 空运货代委托航司代为申报

- o 先确认航司是否提供为货代申报的 ACAS 服务
- o 必须尽早提交, 并且跟航司确认申报结果。


ACAS 空运货代申报资格

- ❖ 所有空运货代,不论一代、二代都可申报。
- ❖ 可以跟 E-Fregith 联系, 通过 E-Freight, 向美国海关提交申请表, 申请 Originator code
- ❖ 没有 Originator code, 货代无法自己申报 ACAS

ACAS 空运货代申报方式

→ 美国海关建议及早提交信息, 货代可以在信息还不完整前就发送 ACAS, 我们 ACAS 系统内有两种提交方式, SR 提交 (不完整信息) 和 SF 提交 (完整信息)





- ▲ <u>SF 提交</u>: 当空运货代拿到完整信息, 提交 SF 申报, 让美国海关知道信息已全, 下一步, 等待收到 SF 回执, 货物就可以放心登机。
- ▲ ACAS 的回执,美国海关会提交给航司,所以航司新的 SOP,必然会检查这个回执状态。

What is ACAS

ACAS (Air Cargo Advance Screening) project is a joint effort between Customs & Border Protection (CBP) and Transportation Security Administration (TSA) to screen air cargo shipments inbounds to the United States in order to further reduce the risk of terrorist attacks and raise air cargo supply chain security.

ACAS important Dates

- **June 12, 2018**
 - Air Cargo Advance Screening Program Goes into Effect

ACAS Filing, how far in advance?

- ACAS data should be transmitted prior to consolidation and loading the cargo on an aircraft.
- ♣ This timeline is required to enable risk assessment for each cargo shipment and to conduct the required screening. The sooner data are submitted to ACAS, the sooner screening or Do Not Load (DNL) determinations can be communicated to industry stakeholders, which minimizes the impact to operations.

- Shipper name and address
- Consignee name and address
- Cargo description
- Piece count
- Weight.

ACAS filing preparation

- ❖ Air cargo forwarders should be aware of ACAS regulations for data submission.
 - Contact your Airlines to check if they continue file ACAS for you and if there's any cost after June 12, 2019.
 - Be aware Air AMS filing deadline is 4 Hours before Arrival, but ACAS is preloading.
- ❖ If Air Forwarders like to submit ACAS themselves
 - Contact us for EDI preparation.
 - o **Apply Originator Code**. Each Air Forwarder must have it before transmitting ACAS data.
 - o E-Freight can help to apply originator code from our US Customs Rep.
- Analyze the impact of three type of DNL (Do Not Load) holding messages on air export operation
 - 1) 6H Do Not Load Hold
 - 2) 7H Selectee Data issue Hold
 - 3) 8H Selectee Screening (or Verification) Required Hold

ACAS Background

After 911, AMS, ISF ATS

- Automatic Targeting System
- Automating identification of high risk cargo

Background

The ACAS Pilot was launched in **December 2010** in response to an **October 2010** incident during which concealed explosive devices were discovered in cargo on board aircraft destined for the United States. CBP partnered with the TSA and the private sector to determine a way to interdict such cargo before the departure of the aircraft to the United States. As a result, **CBP**, **TSA** and volunteers from the private sector launched this pilot program **FedEx**, **UPS**, **DHL**, and **TNT**,

How far in advance ACAS data to be submitted?

- ACAS data should be transmitted prior to consolidation and loading the cargo on an aircraft.
- Enough Time for risk assessment and to conduct the required screening.
- The sooner data are submitted to ACAS, the sooner screening or Do Not Load (DNL) can be communicated to industry stakeholders, then minimizes the impact to operations.

Benefits of the ACAS program

Reduce the risk of terrorist attacks

Raise air cargo Supply Chain Security

Reducing paper processes

Gained efficiencies by automating identification of high-risk cargo before it is consolidated and loaded on U.S.-bound aircraft

Who's responsibility?

Who can submit ACAS data to CBP?

- 1. Air Carrier if no other eligible party elects to file.
- 2. Air Consolidator (一代)
- 3. Air Forwarder (二代)

Early Discussion

- It's better to have the most accurate data at the earliest point possible in the supply chain.
- It's better to have CBP obtains data from the party most likely to have direct knowledge of the data.










ACAS Filing – CBP Process Flow

- ❖ 6月12號即將實施,時間緊張。
- ❖ 公司內部要瞭解ACAS 規章,制定 SOP
- ❖ 確認提交信息準備,減少錯誤回執。
- ❖ 出貨人、收貨人必須正確,位址必須正確。 品名描述不能太簡化,不要太長,不必要的資訊不需 置入,(PO Number)
- ◆ 無論自己申報或給航司申報,盡早準備,提交申報信息。
- ❖ 瞭解DNL,學習如何處理。
- ❖ 最高罰金是五千美金,申報方責任歸屬
